2. **GENERAL TERMS:**

- 2.1. Bidders shall visit the site before submitting the bid.
- 2.2. Bid shall be submitted in a sealed envelope. Bid document (all papers) must be signed and stamped to signify the acceptance of Bid conditions.
- 2.3. Bid without Bid Security will be rejected.
- 2.4. Any conditional Bid will not be accepted and will be liable to rejection.
- 2.5. Prior to making the alphabet contractor shall get its approval from client..
- 2.6. All the works to be carried out under the direct supervision of authorized officer of contractor duly conversant with the work.
- 2.7. Payment to be made after completion of work.

- 2.11. Contractor / Company shall take all measure for safety at workers for the job & no official at State Life will be responsible for any consequences in case of mishap, injury or death of any worker. Company will take all responsibilities to this effect.
- 2.12. If observed in B.O.O. use of fluid / whito / correction, the bid can be rejected.

3. **PRE-BID VISIT:**

All terms & conditions mentioned in this document shall be strictly complied with. 4. **PRICES AND ESCALATION:**

- 4.1. Quoted price shall be inclusive all Taxes, Transportation, Insurance, Octari, loading, unloading, lifting and fixing, testing & commissioning..
- 4.2. No price escalation claim will be entertained due to any reason of change in Taxes, Levy, Wages, Currencies fluctuation or any other change announced by the Central Government / Provincial Government or any local Authority.

5. **MODE OF PAYMENT:**

- 5.1. 1st & Final Bill shall be submitted after completion of work.
- 5.2. 05% Retention Money will be deducted from bill, which will be released after successful completion of period i-e. One (01) Year from date of completion of work.

6. WARRANTY TERMS:

- 6.1. The contractor shall furnish a completion certificate duly verified by Electrical Section that the work has been completed and materials / parts supplied / installed strictly in confirmation to the specification as laid down in the bid.
- 6.2. The contractor will replace the components if not found according to specification or found defective due to faulty design, material or workmanship or being non-genuine.
- 6.3. Any cost of removal, rechecking and cartage charges for defective materials sent back to place of manufacturing shall be borne by the contractor.

7. EXECUTION PERIOD:

The Contractor shall complete the work within Fifteen (15) Days from the Date of Signing of Letter of Award.

8. <u>LIQUIDATED DAMAGES:</u>

Failure to execute the work within the stipulated time contractor will be liable to pay liquidated damages at the rate of Rs. 2,000/ per day of delay subject to maximum10% of Contract price.

9. <u>COMPLETION OF WORK (RISK & COST)</u>

If due to any reason, contractor is unable to complete the work in given time or beyond 100 days of completion date, for which L.D has been imposed on him, SLIC can terminate the contract with him and get the remaining work executed through other contractor at his risk & cost. The cost so incurred will be deducted from his bills or recovered from him through other / legal means.
