- 2. On finding sub-standard quality as and when noticed during process, the deposit security may be forfeited in favour of the Corporation and the Tender may be rejected.
- 3. The Firms/ Suppliers / Distributors in question will be bound to supply the required items as whole consignment within **15** days from the issuance date of supply order.
- 4. The bidders will attach their respective copies of NTN and Sales Tax Certificates. Order will be placed to Quotationers on the lowest items rates.
- 5. Sealed Quotation duly completed in all respects must be reach to the undersigned by Courier Service /Registered Mail or by hand during the office hours i.e 9:00 am to 5:30 pm (sharp) except Saturday & Sunday till closing date & time mentioned above i.e. (08.08.2019).
- 6. The Income Tax will be deducted as per Govt. of Pakistan Rule.
- 7. The Corporation reserves the right to cancel/reject any one or all the Tenders in accordance with rule 33(1) of PPRA.
