- iv. Work should be completed within '30' days from the acceptance of Letter of Award of Work.

- xi. In case of any dispute, Divisional Head (Real Estate) State Life is the final arbitrary authority to settle the matter and it will be liable to accept the decision by both parties. Whereas contractor shall be implied in any action commenced and further to enforce of any decree or order.
- xii. All prevailing government taxes / levies will be borne by the contractor.

If the contractor is unable to finish the work within given time / maximum of 30 days beyond the date of completion, SLIC may exercise the option to terminate the contract and get the remaining work executed from other contractor at his cost & risk. In such case only amount left after deducting the work cost and penalty will be paid with un satisfactory performance certificate to contractor. Moreover, SLIC may further consider Black listing of the Firm / Contractor.
