- **18.** The work executed shall be commissioned and tested in presence of SLIC representative.
- **19.** On completion of work, contractor has to submit the completion certificate.
- **20.** Contractor has to clean the Site in every respect after completion of work.
- **21.** State Life Insurance Corporation of Pakistan will not be responsible for any loss i.e. tool equipment or consumable material and will not accept any claim or compensation.
- **22.** Contractor will be responsible to replace the associate material/equipment under defect liabilities or maintenance period during Six (06) months from virtual completion of work.
- **23.** Payment will be made as per actual quantity work done after the completion of entire work and verified by the State Life representative.
- **24.** Taxes to be deducted as per Govt. Rules.
