GENERAL TERMS & CONDITIONS OF THE CONTRACT

- 1. The bidders should visit the site and satisfy themselves as per site conditions, nature of work and conditions effecting the execution of work in all respect. Claims on the grounds of want of knowledge in such respect or otherwise shall not be entertained.
- 2. The contractor shall take maximum care of adjoining equipment and works, if any damage is caused to such items, the contractor shall rectify the same free of cost to the satisfaction of State Life Engineer.
- 3. The amount of bid security for the tender shall be Rs.2% of bid amount. It is shall be submitted in the form of Pay-order / Banker's Cheque in favor of State Life Insurance Corporation of Pakistan.
- 4. The bid security shall be released to the un-successful bidders after award of work to successful bidder.
- 5. The contractor shall commence the work within (07) days of issuing of letter of award and shall proceed expeditiously without delay and shall complete the works within the time for completion.
- 6. Penalty for late completion of work shall be Rs.4000/- (Rupees Four Thousand Only) per day subject to maximum of 10% of the contract amount.
- 7. Tenders shall be opened on the date and time in the presence of representatives of the contractor of those tenders who wish to be present.
- 8. Incomplete, conditional tender and tender without bid security as specified above shall not be considered at all.
- 9. No escalation shall be allowed. All rates submitted shall be inclusive of cost of import, duties, transport, taxes, sales tax on services imposed by Govt. of Sindh, levies and testing and commissioning etc.
- 10. All technical and other details as required in the tender documents must be furnished with the tender, as no further explanations shall be invited from the tenderer after the tender opening.

- 11. State Life reserves the right to accept or reject any or the entire Tender in the light of PPRA Rules 2004.
- 12. Complete set of tender document must be returned on or before, the tender opening, even if the tender does not wish to participate.
- 13. State Life Insurance Corporation of Pakistan shall accept only standard material strictly in accordance with the specifications & to the satisfaction of Engineer. Any inferior or substandard material if used shall be rejected out rightly and no payment will be made against those.
- 14. If the contractor fails to complete the works within stipulated time, penalty will be imposed as per Clause 11 Salient Features and Clause 6 of the General Terms and Conditions. However if consistently upon reminder the work is not finished within 120 days of letter of award contractor may be black listed, which will be at his sole risk without undergoing any further payment what so ever.
- 15. In case non acceptance of work order issued by State Life, bid security submitted by the contractor will be forfeited.
- 16. All the work executed shall be tested in presence of Engineers of contractor and SLIC. Certificate of completion will be given by State Life after successful testing commissioning of work.
- 17. The rates quoted shall include all prevailing taxes, Octroi, GST etc & no burden to this effect will be added afterwards.
- 18. During defect liability period contractor is required to service equipment monthly and shall be responsible for maintenance & troubleshooting of lift free cost.

19. MANDATORY REQUIREMNTS:

- NTN & SST Registration
- Affidavit on stamp paper that Firm is not black listed any Govt. Autonomous body.
- 05 Years experience of such works/ lift.

20. **DEFECT LIABILITY PERIOD:**

- 1. One (01) year after issuing completion certificate.
- 2. All parts required / replaced during defect liability period shall be provided by contractor free of cost.
