# **GENERAL TERMS & CONDITIONS OF THE CONTRACT:**

Bid shall be submitted in a sealed envelope. Bid document (all papers) must be paged down / signed/ stamped and flagged to signify the acceptance of Bid conditions.

The successful supplier will be required to submit the schedule of supply and installation within **Seven (07) Days** from the date of acceptance of Letter of Award.

Bid without Bid Security will be rejected.

Any conditional Bid will not be accepted and will be liable to rejection.

Contractor has to clean the site in every respect from unused material, debris and tools on completion of work.

All the works to be carried out under the direct supervision of respective building in charge / SLIC representative.

State Life Insurance Corporation of Pakistan will not be responsible for any loss to life or theft of tool / equipment or consumable material and will not accept any claim, liabilities or compensation.

#### PRE-BID VISIT:

Bidders are requested to visit the site before submission of bid and ensure that their offers are complete in all respect. All terms & conditions mentioned in this document shall be strictly complied with. Bidder must ensure/study the specifications, schedules and B.O.Q to avoid any debate/discussion/dispute during/after execution of work.

No TA/DA will be given to Bidders for Pre-Bid Visit.

#### **PRICES AND ESCALATION:**

1. Quoted price shall be inclusive all Taxes of Supply, Transportation, Insurance, loading, unloading, lifting and fixing of equipment at Site, as specified in the Bid. 2. No price escalation claim will be entertained due to any reason of change in Taxes, Levy, Wages, Currencies fluctuation or any other change announced by the Central Government / Provincial Government or any local Authority.

#### MODE OF PAYMENT:

- a) 40% Payment upon successful supply of items as per BOQ.
- b) 50% payment upon satisfactory installation. testing, commissioning of lift.
- c) 10% after successful completion of **defect liability period i-e. Six (06) month** from date of completion of work.

#### DEFECT LIABILITY PERIOD:

- 1. The contractor shall furnish a completion certificate that the work has been completed and materials / parts supplied / installed strictly confirm to the specification as laid down in the contract.
- 2. The contractor will replace the components if not found according to specification or found defective due to faulty design, material or workmanship or being non-genuine.
- 3. Cost of removal, rechecking and cartage charges for defective materials sent back to place of manufacturing shall be borne by the contractor.

### DELIVERY AND EXECUTION PERIOD:

The Contractor shall Supply & Replace all items within **thirty (30)** Days from the date of commencement of work.

#### LIQUIDATED DAMAGES:

Failure to execute the work within the stipulated time will render contractor liable to payment of liquidated damages at the rate of 0.5% per day of delay subject to maximum10% of Contract price.

#### SIGNING OF CONTRACT AGREEMENT:

1. Upon acceptance of the Bid the company / supplier shall execute a proper agreement on non-judicial stamp paper with the State Life Insurance Corporation of Pakistan containing certain terms and conditions in the form prescribed by the State Life Insurance Corporation of Pakistan within **Seven (07)** days from the acceptance of Letter of Award.

#### TERMINATION.

After 30 days of the date of completion, if the works remain incomplete, SLIC may exercise the option to terminate the contract and get the remaining work executed from other contractor at his cost & risk. In such case only amount left after deducting the work cost and penalty will be paid with un satisfactory performance certificate to contractor. Moreover, SLIC may further consider Black listing of the Firm / Contractor.
