1. <u>GENERAL TERMS:</u>

- 1.1. The tender is invited to the hiring of Consultancy and Project Management Services for Installation of Solar System at State Life Building 34 The Mall, Peshawar & State Life Building No.11, Davis Road, Lahore.
- 1.2. Tender shall be submitted in a sealed envelope.
- **1.3.** Bidders are requested to visit the location (if required) and ensure that their offers are completed in all respect and that all terms & conditions mentioned in this document shall be strictly complied with. Bidders must study the scope of work to avoid any debate/ discussion/ dispute during/ after execution of work.
- **1.4.** All papers of Tender documents must be signed and stamped to signify the acceptance of tender conditions.
- **1.5.** State Life Insurance Corporation of Pakistan (SLIC) reserves right to accept/ reject the lowest or any tender received in light of PPRA Rules.
- 1.6. Tender without Bid Security will be rejected.
- 1.7. Any conditional Tender will not be accepted and will be liable to rejection.

2. PRICES AND ESCALATION:

- 2.1. Quoted price shall be inclusive all overheads, profits, SST, taxes, surcharges and preparatory works as required and no escalation or extra payment shall be considered on any of these account or reason.
- 2.2. No price escalation claim will be entertained for any reason due to change in Taxes, Levy, Wages, Currencies fluctuation or any other change announced by the Federal Government/ Provincial Government or any local Authority.

3. <u>MODE OF PAYMENT:</u>

- **3.1.** Payment will be released as per method of payment given in the special conditions.
- **3.2.** 5% Retention Money will be deducted from the bill which will be released after defect liability period (i.e., 06 months) after successful commissioning of solar system & its net metering.

4. **DEFECT LIABILITY PERIOD:**

4.1. Defect liability period of six (06) months will be started from the date of completion certificate issued by Consultant. Completion certificate will be effective from successful completion of works by contractor and net metering with PESCO/ LESCO. The consultant shall furnish a completion certificate that the job has been completed and materials supplied strictly confirm to the design and specifications as laid down in the contract with contractor.

5. <u>DELIVERY AND EXECUTION PERIOD:</u>

The consultant shall perform their duty from the date of signing of their contract till successful completion and operations of solar system and net metering by the contractor. The timeline to be given to contractor for installation of solar system will be 90 days after vetting and approval of design by consultant and 01 month for net metering.

6. <u>LIQUIDATED DAMAGES:</u>

Failure to provide the services within the stipulated time will render the consultant liable for payment of liquidated damages at the rate of 0.25% of contract amount per day of delay subject to max. to 10% of Contract amount. If the services are not made in the given time & after 50 days of final date, SLIC can terminate the contract and start backlisting process against the consultant and get the balance work done from any other consultant at his risk & cost.

7. SIGNING OF CONTRACT AGREEMENT:

- 7.1. Upon acceptance of the tender the consultant shall execute with State Life Insurance Corporation of Pakistan a proper agreement on a non-judicial stamp paper of containing certain terms and conditions in the form prescribed by the State Life Insurance Corporation of Pakistan (SLIC) within seven (07) days from the acceptance of Letter of Award.
- 7.2. The contract shall be Governed and interpreted in all respects in accordance with the Law of Pakistan.
