- 2). The tenders received <u>after the due date and time, will not be entertained</u>. Responsibility of in time delivery of tenders rest with the bidders.
- 3). The validity of tender will be up to the date of opening of the tender.
- 4). Submission of complete profile of the Vendor/Firm/Organization/Company is <u>mandatory</u>, narrating, (work experience, marketing strength, registration with FBR etc). If no profile is submitted the bid will not be entertained.
- 5). The supply should be made <u>within ten days</u> after the opening of the tender by the successful vendor/supplier. In case of failure, of item delivery or supply order the earnest money will be forfeited without serving any notice.
- 6). Incomplete offers received and not according to criteria shall not be considered.
