The second envelope containing the price Tender Documents shall be clearly marked as "FINANCIAL BID DOCUMENTS" accompanied with Bid Security @ 05% of bid amount in favour of State Life in the form of Pay Order, Demand Draft, CDR.
- 4- The sealed quotations should reach to the Secretary Zonal Procurement Committee, State Life, Zonal Office, Queens Road, Sargodha upto 11:00 on 11th October 2019. The Envelop must bear the title of Tender at its right hand corner.
