## **TERMS AND CONDITIONS**

- 3. Bidders should provide the name of firm, complete postal address, Telephone No, Fax No, Email address and web address (if any).
- 4. Bidders are required to submit their bids in a sealed large envelope, clearly marked "Supply of Furniture Fixture / Office Equipment Items for Various Chief(s)" This envelope should contain two smaller sealed envelopes clearly marked "Technical Proposal" and "Financial Proposal" respectively.
- 5. Initially only Technical Proposals will be opened in the office of Deptt'l. Head (GS), State Life, Principal Office, 2<sup>nd</sup> Floor, State Life Building # 9, Dr. Ziauddin Ahmed Road, Karachi, on the date and time as specified in the specifications & quantities /schedule above, in the presence of bidders or their representatives. Time and date for opening of Financial Proposals will be announced after finalization of Technical Evaluation.

- There will be a two-stage evaluation of bids. Technical evaluation will be held first. Minimum overall 60% and in each category as well is required for the bidders to technically qualify. Financial bid of only technically qualified bidders would be opened.
- i) Experience of bidders in sales / marketing of relevant equipment.
- ii) Financial Capabilities.
- iii) Number of existing clients provided with similar equipment.
- iv) List of professionals on permanent strength- for installation and after sales services (Technical evaluation of bids / point scoring criteria is available with bidding document).
- 7. Most Advantageous Bid would be accepted (item wise).
- 8. Financial Proposals shall accompany a Pay Order/Bank Draft of the 5% of the total bid amount in favor of State Life Insurance Corporation of Pakistan as bid security. The same will be returned immediately to un-successful bidders after completion of formal procedure and to successful bidder after satisfactory delivery of all items.
- 9. No bid will be accepted without bid security.
- 10. All the bids must include all government taxes.
- 11. The bids submitted shall hold good for a minimum period of 90 days from the date of bid opening.
- 12. The quantity of items may vary at the time of issuing job order.
- 13. If the successful bidder fails to supply the items as per purchase order, the bid security will be forfeited. In case of a genuine reason regarding delay in delivery the successful bidder shall inform immediately and the delivery time may be extended at the discretion of state Life.
- 14. Competent Authority reserves the right to reject all bids or proposal any time prior to the acceptance of a bid or proposal in the light of PPRA rules.
- 15. All the information provided by the bidder must be verifiable.
- 16. Earnest money of the successful will be forfeited if the items are not delivered within due time/ extended delivery time or as per approved quality.
- 17. After Technical Evaluation of the submitted documents, all the participating bidders will be required to bring one sample of each item for approval (as per approved quality). Financial bids of only technically qualified bidders (those bidders whose documents have been found correct and sample item approved as well) will be opened.
