- ii. Replacement of consumable parts i.e. all type filters and other Generator parts as specified manufacture in original on actual basis will provide by contractor, the cost of all consumable spare / allied parts will be paid by SLIC. The quotation will be sent by contractor for prior approval.
- iii. Major repair and replacement of engine or alternator parts, radiator and major overhauling of equipments shall carry out by contractor will be billed to State Life at actual cost also corrective maintenance job will be quoted separately for approval.
- iv. Contractor will get signature by SLIC representative on field service.
- v. Contractors will intimate before routine service visit.
- vi. Detail of maintenance and service are mentioned at Annexure –A
- vii. Any modification of the equipment of facilities shall be carried out by contractor outside the scope of this maintenance at rate to be mutually agreed
- viii. Defects rectification and maintenance of equipment shall be carried out by qualified / trained contractor Engineers /' staff
- ix. Contractor will provide backup canopied Generator / standby power with suitable rating on rent at mutual agreed rates in case existing D.G Set is under repair for undefined period.
