<u>Terms and Conditions of the Tender for Provision of Eligibility / Know Down</u> <u>Criteria for Qualifying as Security Services Provider.</u>

- 1. Tender will be opened in the Office of In-charge (P&GS) Department / Secretary ZPC Sukkur Zone in the presence of the Bidders or their representatives.
- 2. The quotations received after the due date & time will not be entertained. The in-time collection/submission of tender will be exclusive responsibility of the bidder.

- 3. The Validity of tender will be from the date of opening/acceptance of tender.
- 4. The security guards should be ex-army men and will have to perform their duties with uniform 12 Clock in 24 hours 24/7 days.
- 5. The submission of Professional Tax Certificate shall be mandatory for bidder.
- 6. All rates should be mentioned inclusive of all taxes.
- 7. Bidders are required to remit 05% of their bid (refundable) being earnest money in shape of Pay Order/DD in the name of State Life Insurance Corporation of Pakistan, otherwise bid will not be accepted.
- 8. The number of Security Guards can be increase/decrease as per requirement.
- 9. The Company will replace/rotate their Security Guards as per instructions issued by State Life on regular basis.
- 10. The work order will be given after signing of contract mutually.
- 11. The contract will be given for Three years, and effective from the date of approval of competent authority. In future the said contract can be renewed with same terms & conditions if mutually agreed upon.
- 12. The security company will have to provide 12 bore Repeater or equivalent weapon to its guards.
- 13. SRB Certificate.
- 14. NTN Certificate from FBR.
- 15. Professional Certificate, Government of Sindh.
- 16. Bank Turnover / Statement showing 100.00 million last year.
- 17. Proof of FBR Return of three years.
- 18. Relevant experience of at least five (5) years in any organization (Government, Semi-Government & Private Company) with documentary evidence.
- 19. Registration with Social Security & EOBI.
- 20. NOC from Ministry of interior Government of Pakistan

- 21. Original Authority letter for Participation in the Tender meeting.
- 22. Firm should have setup in Sukkur (Attached utility bill (or) PTCL bill in the name of Firm for verification).
- 23. Undertaking @ 100/- Non Judicial stamp paper that the firm is not blacklisted in anywhere in Sindh / Pakistan (Note: Photocopy is not allowed).
- 24. Audit report of last year.
- 25. Firm should have to permission letter of Firing Practice from Local District Police Office. (Attached documentary evidence mandatory).
- 26. Competent Authority reserves the right to accept or reject all bids or proposal at any time prior to acceptance of a bid or proposal. However, State Life on request shall communicate any contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals. The tenders shall be required to quote the rates inclusive of all taxes.

Note: Bidder should ensure that quoted rates are according to minimum wages as notified/announced by Government of Pakistan, the quoted rates should include amount of minimum wages, EOBI, SESSI, all taxes and other expenses.
